Lottery Enrollment Agreement

The following sets forth the terms and conditions relating to the arrangement between the Player who is participating "client player" and **Lucky88**.

1. Eligibility

The Player client is a natural person over the age of 18 years and is a Filipino Citizen.

2. Ownership

The player client shall have a joint interest in any ticket and all the proceeds of any prize claimed by the parties as tenants in common. Each Ticket is assigned with 88 client players. Each client player shall have a 1/88 ownership interest in any such ticket and proceeds. **Lucky88** will acquire and hold for the parties all ticket purchases. A duly assigned representative of **Lucky88** may claim the prize for any winning ticket; however, only after the winning ticket claim of **Lucky88** is approved by the Philippine Charity Sweepstakes Office, will the winning amount for the ticket be announce in the site, this said amount prize will then be divided among the parties in that winning Pot in accordance with each party's interest.

3. Taxes

Each client player specifically agrees and acknowledges its responsibility and accountability for the payment of its own taxes on income received both from the structure and from the joint ownership of lottery tickets as well as filing any required forms with the Bureau of Internal Revenue Service or the appropriate local authorities.

4. Termination of Agreement

In the case of death of Client Player, any and all prize money due to the deceased Player shall be paid to his or her estate. On the event of dissolution of Lucky88, any and all prize money due to Lucky88 shall be paid to its successor in interest.

5. Disclaimer

Lucky88 shall have no duty to purchase tickets for joint ownership or claim the prize for any winning ticket if prevented from doing so by acts of God, the actions of any lottery commission, federal state and local governments, or for any reason beyond the control of Lucky88 and its agents or employees.

6. Erroneous Information

A permanent record will be made of the assigned numbers corresponding to each Original Philippine Lottery Ticket bought to be played for each player. In the event a wrong information (**wrong pot (pool number assigned per ticket with 88 client players) number**) is sent to a client player, the said client player shall not be entitled to any claim based on the receipt of erroneous information. The pot number actually assigned by Lucky88 with corresponding Official System Ticket purchased on behalf of the Player will control. Player must immediately notify Lucky88 upon receipt of erroneous information. Player hereby waives any right and/or claim against Lucky88 for the failure to obtain or send the properly assigned Pot for their ticket numbers.

7. Accepting this Arrangement.

This Agreement will be effective upon the time when the client player registers in Lucky88 and selects which ticket the client player would like to purchase. Payment has to be made for the services of Lucky88 to purchase such selection in behalf of the client player. This will continue until the earlier of the date on which Lucky88 cannot book the client player for the next succeeding draw for there is no more cash in the client players Virtual Account and/or client player has not made a deposit in the bank or gave payment to a retailer to move funds virtually to client players virtual account for the next draw. This signifies that the client player does not want to purchase another system ticket thru Lucky88 and not avail of the incentives in its affiliate program, the Lucky88 Rewards System. Therefore player client will not receive any commissions from his down lines for that specific draw date.

9. Refunds for unprocessed orders

In cases where the customer client will end up at the last pot (last ticket) to be filled up for a particular draw date and minimum number of players are not reached in each last system ticket, those customer clients in that last pot will still receive their commissions due from Lucky88 Rewards System.

All players in the unfilled pots will automatically be assigned to the system 8 ticket for that particular draw. All players in the 3 System plays with unfilled pots will be pooled to the system 8 pot. Lucky88 will fill up remaining slots to fill up the last system 8 ticket pot that comprises of the unfilled number of people in the system 9 and system 11 ticket pot.

10. Cut-off times

Purchases to succeeding draws is done every Wednesdays, Fridays, and Mondays at exactly 8:30 am Philippine time. Cutoff in receiving new registries and purchases for a particular draw date will be at 3:00pm on that draw particular draw date. This cutoff allows ample time for Lucky88, to withdraw cash, purchase in behalf of the customer clients the original system play tickets of the Philippine Lottery, assign, scan and upload the original tickets in the website for the customer clients to see.

11. Liability

Lucky88 cannot be held liable for any late notification of entries for a particular draw. It is the responsibility of the customer client individual to ensure that their orders are placed on time for a draw and they are aware of the cut-off times for the draws. If the individual customer clients virtual account is not deducted and does not receive a confirmation, then they must be aware that the minimum number of customer clients in a particular pot was not met. Therefore, no ticket assignment for that draw date but still receives his commissions thru Lucky88 Rewards system if applicable.

12. Winning Tickets

We do not mail winning tickets (or any tickets), the winnings are collected on your behalf and will be credited to the winning pools individual virtual accounts according to the percentage share of ownership per customer client in that particular winning ticket. Each customer client under that winning pool ticket number then chooses how and what to do with their winnings individually.
